#### Q. What is the news?

**A.** McKesson Corporation has acquired all outstanding shares of PSS World Medical Inc. McKesson Medical-Surgical, the parent company of Cypress Medical Products and others, and PSS World Medical have combined to form a leading alternate site distribution company in North America.

#### Q. Why did McKesson decide to merge with PSS World Medical?
